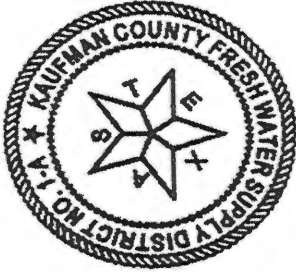

Harwood Street, Suite 500, Dallas, Texas 75201, an office located outside the boundaries of the District, for the following purposes:

1. Call to order;
2. Public comment and communication;
3. Review and approve Minutes of December 5, 2019 Board of Directors meeting;
4. Consider review and acceptance of engineer's report, and take any action necessary or appropriate;
