Pursuant to an Order of the Governor suspending certain requirements of the Texas Open Meetings Act, the Board of Directors of Rockwall County Municipal Utility District No. 7 (“District”) will hold a regular meeting on **Tuesday, April 28, 2020 at 5:30 pm solely by telephone conference** to mitigate the spread of COVID-19. The meeting will be conducted in a transparent and accessible manner pursuant to the guidance provided by the Office of the Attorney General. 1. Public communications and comments;
2. Review and approve Minutes of February 25, 2020, Board of Directors meeting;
3. Hear report from engineer, including authorization of any advertisements for construction of additional District improvement projects as may be necessary; award any construction contracts, approve any pay applications or change orders relating to on-going projects and hear all engineering related updates and take any action as may be necessary;
4. Consider authorizing LJA Engineering, Inc. to accept electronic bids pursuant to Texas Water Code Section 49.2731, and take any action as may be necessary;
5. Hear report from developer and take any action in connection with plat approval, reimbursement agreements or assignments thereunder, or other development related items;
6. Consider discussion regarding tax exemptions, and take any action as may be necessary;
7. Review and approve bookkeeping report, and take action on bookkeeping related matters including, but not limited to; quarterly investment reports, investment recommendations, new account related matters, authorize the release of checks as noted on such report, and review existing budget related matters;
8. Consider authorizing bookkeeper to disburse funds approved on the bookkeeping report pursuant to Section 49.151, Texas Water Code, and adopt resolution related thereto;
9. Discuss tentative date for next meeting; and
10. Adjournment.
