5. Consider approve and accept facilities relative to completion of improvements in Woodcreek Phase 2D-3; authorize conveyance of facilities, and take any action as may be necessary;
6. Consider, review and approve Resolution Requesting Use of Surplus Funds, and take any action as may be necessary;
7. Hear report from developer and take any action in connection with plat approval, reimbursement agreements, or assignments thereunder, or other development related items;
8. Review and approve bookkeeping and tax collection reports, and take any action on bookkeeping related matters including quarterly investment reports; investment recommendations; new account related matters; authorize release of checks as noted on report;

9. Acknowledge receipt and conduct annual review of Arbitrage Rebate and Yield Restriction Compliance Service Program and related Rebate Summary prepared by Arbitrage Compliance Specialists, Inc.;
