Notice is hereby given pursuant to Section 551 of the Texas Government Code, and the March 16, 2020 action of the Office of the Attorney General suspending certain requirements of Section 551, that the Board of Directors of Crosswinds Municipal Utility District will hold a regular Board meeting at **11:00 a.m.** on **Thursday, July 9, 2020.**

In an effort to mitigate the spread of COVID-19 and pursuant to the Proclamation dated March 13, 2020 by Governor Greg Abbott (declaring Texas to be in a State of Disaster) and associated Press Release dated March 16, 2020 from the Texas Attorney General's office and the extension thereof (suspending certain requirements of the Texas Open Meetings Act), the District will be conducting this meeting by telephone conference. 
1. Hear public communications and comments (3 minutes per person; no action may be taken during the public comments);
2. Review and approve Minutes of June 11, 2020 Regular Board meeting;
3. Consider and approve new Contract for Municipal Solid Waste Collection and Disposal Services with Texas Disposal Systems, Inc.;
4. Hear report from engineer, review of any bids received and recommendation letter from engineer as to award of contract, status of contract awards, authorizations for additional contract advertisements, review and approvals of any needed plat approvals, pay applications or change orders under existing contracts, partial or final acceptance of any projects, approve any necessary assignment of easements or conveyance of facilities, review and approve any recommendations for maintenance and improvement projects and related matters and take necessary action with respect thereto;
5. Consider and approve Order Adopting Electronic Bidding Rules;
6. Hear report from developer and take any necessary action with regard to existing developer reimbursement agreement or assignments thereof;
7. Hear report from District's attorney as to any additional water and sewer related agreements, amendments to existing agreements, easements, conveyances to the City of Kyle or other related matters and take any necessary action;
8. Review bookkeeping report including payments of District routine operating expenses, tax collections, status of builder invoicing and receipt of payments, fund wires as needed, review of operating budget and approve checks and wires as set out in such report, approve any additional authorizations as may be needed regarding bookkeeping matters;
9. Consider and adopt Amended Order Adopting Investment Policy and Appointing Investment Officer;
10. Hear Operations Report and take any necessary actions;
11. Discuss and authorize initial District website;
12. Discuss, and if timely, review and approve agreement or contract in connection with additional tax related services;
13. Review the District's 2020 Preliminary Values from the Hays Central Appraisal District and authorize the preparation of necessary tax rate worksheets and proposed Notice of Tax Rate Hearing for adoption at the August meeting;
14. Adjourn to Executive Sessions to consultant with attorney, regarding pending litigation matters, contemplated litigation matters, and other legal matters relating to agenda items in accordance with Texas Government Code § 551.071;
15. If necessary, reopen meeting and take any necessary action with regard to matters discussed in Executive Session;
16. Discuss timing of next regular meetings and any additional proposed special meetings; and
17. Adjournment.

The Board of Directors will go into Executive Session, if necessary and appropriate, pursuant to the applicable section of Subchapter D, Chapter 551, Texas Government Code Annotated, the Texas Open Meetings Act, on any matter that may come before the Board.
