Pursuant to an Order of the Governor suspending certain requirements of the Texas Open Meetings Act, the Board of Directors of Kaufman County Fresh Water Supply District No. 1-A will hold a public meeting on **Thursday, November 5, 2020 at 1:00 pm solely by telephone conference** to mitigate the spread of COVID-19. The meeting will be conducted in a transparent and accessible manner pursuant to the guidance provided by the Office of the Attorney General. **Any member of the public may participate in this meeting by dialing: (888) 594-6783; and entering passcode 214 745 5691#.** Electronic copies of Board meeting packets are available upon request by email to Ross Martin at rmartin@winstead.com. This meeting will also be recorded and available for electronic distribution. The following items will be considered:

1. Call to order;
2. Public comment and communication;
3. Review and approve Minutes of October 1, 2020 Board of Director meetings;
4. Consider review and acceptance of engineer's report, and take any action necessary or appropriate;
 - a. Status of construction projects within the District;
 - b. Consider authorizing preparation of construction plans/specifications for water, sewer, drainage, paving and recreational facilities or repair/modification of existing facilities;
 - c. Consider approval/ratification of construction plans and specifications;
 - d. Consider approval/ratification of advertising for bids for contract(s);
 - e. Consider approval/ratification of award of construction contract(s);
 - f. Consider approval/ratification of contractor pay estimates, change orders and engineering fee statements;
 - g. Consider acceptance of certificate of completion; authorize final acceptance of facilities; and
 - h. Consider approval/ratification of repair and/or maintenance of District facilities.
5. Hear report from developer and take any action in connection with plat approval, reimbursement agreements or assignments thereunder, or other development related items;
6. Ratify and approve engagement letter with Saunders, Walsh & Beard, and take any action necessary or appropriate therewith;
7. Consider review and approve Amendment to Agreement Regarding Wastewater Treatment Service with the City of Forney, Texas, and take any action necessary or appropriate therewith;

8. Consider review and approve Second Amendment to Joint Utility and Wholesale Allocation Agreement, and take any action as may be necessary or appropriate;
9. Consider review and approve Operating Agreement by and between the District and Kaufman County Fresh Water Supply District No. 1-D, and take any action necessary or appropriate therewith;
10. Consider review and acceptance of operator's report, and take any action necessary or appropriate, including authorizing or ratifying repair of District facilities, and consideration of contract for cellular service in connection with electronic monitoring of District facilities;
11. Consider review and approval of bookkeeping report, payment of invoices, bank resolutions, budget, and related bookkeeping matters;
12. Discuss tentative date for next meeting; and
13. Adjournment.
