

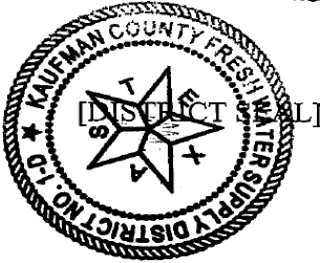

Pursuant to an Order of the Governor suspending certain requirements of the Texas Open Meetings Act, the Board of Directors of Kaufman County Fresh Water Supply District No. 1-D will hold a public meeting on **Thursday, November 5, 2020 at 12:00 p.m. solely by telephone conference** to mitigate the spread of COVID-19. This meeting will also be recorded and available for electronic distribution. The following items will be considered:

 - a. Status of construction projects;
 - b. Consider authorizing preparation of construction plans and specifications;

 - d. Consider approval of advertising for bids for contract(s);
 - e. Consider approval of award of construction contract(s);
 - f. Consider approval of contractor pay estimates/engineering fee statements;
 - g. Consider acceptance of completion; authorize final acceptance of facilities; and
 - h. Consider conveyance of completed District facilities.

6. Hear report from developer;
7. Consider patrol activity report, and take any related action;
8. Consider review and approve Second Amendment to Joint Utility and Wholesale Allocation Agreement, and take any action as may be necessary or appropriate;
9. Consider review and approve Operating Agreement by and between the District and Kaufman County Fresh Water Supply District No. 1-A, and take any action necessary or appropriate therewith;

10. Consider review and approve bookkeeping report, payment of invoices, bank resolution, budget, and related bookkeeping matters;
