6. Confirm receipt of 2021 certified tax roll prepared by Rockwall Central Appraisal District, consider authorizing tax rate calculation services; adopt resolution;
7. Review tax rate recommendation, approve proposed tax rate for 2021, adopt Notice of Water District Hearing on Tax Rate, and authorize publication;
8. Review and approve bookkeeping report, take action on bookkeeping related matters including, but not limited to; quarterly investment reports, investment recommendations, new account related matters, authorize the release of checks;
9. Consider review and approve operating and debt service budgets for fiscal year ending August 31, 2022, and take any action necessary or related thereto;

10. Consider review and acknowledge correspondence from McCall Gibson Swedlund Barfoot PLLC in connection with auditor services for fiscal year ending August 31, 2021;
11. Consider review and approve engagement letter for arbitrage compliance services;
12. Discuss tentative date for next meeting; and
