Notice is hereby given pursuant to V.T.C.A., Government Code §551, that the Board of Directors of North Fort Worth Water Control and Improvement District No. 1 of Denton and Wise Counties (“District”) will hold a regular meeting on Thursday, October 14, 2021, at 11:30 a.m. at Rudy’s Country Store and Bar-B-Q at 520 Interstate 35 Frontage Road, Denton, Texas 76205, for the following purposes:

1. Public comment and communications;
2. Review and approve Minutes of the August 26, 2021, Board of Directors Meeting;
3. Consider and approve renewal of District insurance coverages;
4. If timely, consider authorization of District consultants to prepare and submit application for use of surplus funds to the Texas Commission on Environmental Quality, adopt resolution related to same, and take any other action as may be necessary;
5. Hear report from developer or engineer and take any action in connection with plat approval, reimbursement agreements or assignments thereunder, or other development related items;
6. Consider review and acceptance of Engineer’s Report, and take any action necessary or appropriate;
 - a. Status of construction projects within the District;
 - b. Consider authorizing preparation of construction plans/specifications for water, sewer, paving and recreational facilities or repair/modification of existing facilities;
 - c. Consider approval/ratification of construction plans and specifications;
 - d. Consider approval/ratification of advertising for bids for contract(s);
 - e. Consider approval/ratification of award of construction contract(s);
 - f. Consider approval/ratification of contractor pay estimates, change orders and engineering fee statements; and
 - g. Consider acceptance of certificate of completion; authorize final acceptance of facilities.
7. Review and approve Bookkeeper’s Report and payment of bills, reimbursement of developer, review of financial statements, review and approval of tax collection report, budget items and investment reports;
8. Discuss and set date of next Board meeting; and

9. Adjournment.

The Board of Directors may enter into Executive Session, if necessary and appropriate, pursuant to the applicable section of Subchapter D, Chapter 551, Texas Government Code Annotated, the Texas Open Meetings Act, on any matter that may come before the Board. No action, decision or vote on any subject or matter may be taken unless specifically listed on the agenda for this meeting.
