Hwy. 71 West, Suite 160, Austin, Texas** or by Zoom video conference in accordance with the subsequent paragraph. Members of the public who wish to attend the meeting in person are expected to comply with any applicable physical distancing and other governmental requirements.

1. Public communications and comments (3 minutes per person, no action may be taken during public comments);
2. Review and approve Minutes of February 15, 2022 Board of Directors meeting;
3. Review letter confirming unopposed candidates and consider and adopt an Order Declaring Unopposed Candidates Elected and Cancelling Directors Election;
4. Reelect officers to be effective May 7, 2022;
5. Hear report from developer on status of development;
6. Hear report from engineer, review of any bids received and recommendation letter from engineer as to award of contract, status of contract awards, authorizations for additional contract advertisements, review and approvals of any needed plat approvals, pay applications or change orders under existing contracts, partial or final acceptance of any projects, approve any necessary easements, assignment of easements, encroachment agreements or assignments thereof, or conveyance of facilities, review and approve any recommendations for maintenance and improvement projects and related matters and take necessary action with respect thereto;
7. Update with regard to Master Drainage Plan and take any action, as may be necessary, with respect thereto;
8. Hear report from attorney for the District as to any additional water and sewer related agreements, easements, assignments, rights-of-way, related cost sharing agreements, etc. or other related matters and take any necessary action;
9. Review and approve bookkeeping report and authorize the release of checks and payments included in such, or budget related matters, and take any additional action as may be necessary;
10. Review and confirm annual renewal of insurance and bonds;
11. Discuss and confirm tentative next meeting date; and
12. Adjournment.
