Notice is hereby given pursuant to V.T.C.A. Government Code, Section 551, that the Temporary Board of Directors of Mustang Ridge Municipal Utility District will hold an Organizational Meeting on Thursday, January 20, 2022 at 10:30 a.m. at 12934 Elm Grove, Buda, Texas 78610 for the following purposes:

1. Review and acknowledge Legislation (House Bill 4627, 87<sup>th</sup> Session of the Texas Legislature, Regular Session) creating the District and appointment of directors;
2. Confirm receipt of Order from the Texas Commission on Environmental Quality appointing temporary directors;
3. Qualify temporary directors and administer statement of officer forms and oaths of office;
4. Review insurance proposal and approve placement of directors' and officers' liability insurance, bonds and other insurance deemed appropriate at this time;
5. Elect officers;
6. Hear overview of District and report on status of proposed development;
7. Consider and approve separate legal engagements of Andy Barrett & Associates PLLC and Winstead PC, and execute related agreements;
8. Consider and approve engagement of Doucet & Associates as engineer for the District and execute related agreement;
9. Consider and approve engagement of The GMS Group, L.L.C. as financial advisor for the District;
10. Consider and approve engagement of Bott & Douthitt, PLLC as bookkeeper for the District and execute related agreements and approve necessary authorizations;
11. Consider and designate depository bank and authorize the opening of an operating account and execution of required account documents, including signature cards and related bank resolutions;
12. Consider and ratify prior actions taken and the payment of various out-of-pocket expenses made on behalf of the District;
13. Authorize any negotiations with regard to the City of Mustang Ridge, Texas, Travis County, Texas, water and wastewater service providers, and additional service providers, as may be necessary, with regard to various agreements and related matters, and authorize negotiations in pursuit of a wastewater permit application through the Texas Commission on Environmental Quality and execution and filing of any documents related to same;
14. Adopt Order Designating Office Locations Outside the District and authorize publication of Notice of same;
15. Consider and adopt Resolution Designating Posting of Meeting Notices for meeting notices posted within the District;
16. Adopt District seal;
17. Approve and authorizing filing of District Information Form;
18. Review and approve Order Adopting a Travel Expense Policy, Limit on Fees of Office and Procedures for Selection and Review of Consultants, Policies Concerning the Use of Management Information, Including the Formation of an Audit Committee, Establishment of an Investment Policy, Selection of a Fiscal Year-End and Certain Other Matters;
19. Review and approve Order Approving Records Management Policy and Designating Records Manager;
20. Consider and act upon items in supplemental agenda;
21. Authorize the creation of a District website;
22. Discuss and confirm proposed next meeting date;
23. Public communications and comments – no formal Board action will be taken; and
24. Adjournment.

The Board of Directors will go into Executive Session, if necessary and appropriate, pursuant to the applicable section of Subchapter D, Chapter 551, Texas Government Code Annotated, the Texas Open Meetings Act, on any matter that may come before the Board. No action decision or vote on any subject or matter may be taken unless specifically listed on the agenda for this meeting.
