The Board of Directors (the "Board") of Rockwall County Municipal Utility District No. 7 (the "District") met in regular session by audio conference, open to the public, on Tuesday, August 25, 2020, at 5:30 pm.

Ms. Sarah Landiak, General and Bond Counsel for the District, announced that the Meeting would be conducted by audio conference to mitigate the spread of COVID-19. Ms. Landiak confirmed that Meeting participants will observe guidance provided by the Texas Attorney General's office to suspend certain requirements of the Texas Open Meetings Act. Ms. Landiak next stated that (i) Notice of the Meeting was given in accordance with Chapter 551, Government Code, and Chapter 49, Texas Water Code, as amended by the Governor's order and Attorney General's guidance; (ii) the Meeting was being conducted in a transparent and accessible manner; (iii) Meeting packets were distributed to all participants, and made available to the public; and (iv) the Meeting would be recorded, and available for electronic distribution upon request.

The meeting was called to order at 5:32 p.m.

- 1. <u>Public Communications and Comments</u>. Ms. Landiak opened the meeting for public communication and comment. After noting that there were no members of the public present, Director Christensen moved that the Board close the public communication and comment session of the meeting. Director Cook seconded said motion, which carried unanimously.
- 2. <u>Conduct Hearing Regarding District's Proposed 2020 Tax Rate</u>. Director Jones moved that the Board convene a public hearing regarding the District's proposed 2020 tax rate. Director Skinner seconded said motion, which carried unanimously. The President then convened

In order to mitigate the spread of COVID-19 and pursuant to the Proclamation dated March 13, 2020 by Governor Greg Abbott declaring a state of disaster and associated guidance dated March 16, 2020 from the Texas Attorney General's office (collectively, the "Open Meetings Guidance"), suspending certain requirements of the Texas Open Meetings Act, the Board of Directors (sometimes referred to as "Board") of Rockwall County Municipal Utility District No. 7 ("District"), after due notice, conducted a special telephonic Board meeting pursuant to the requirements set out therein and subject to the Open Meetings Guidance referenced above, which included telephone access to the meeting by the public, on August 25, 2020; whereupon the roll was called of the members of the Board of Directors, to-wit:

Order thus adopted is as follows:

WHEREAS, the appraisal roll of Rockwall County Municipal Utility District No. 7 (the "District") for 2002 has been prepared and certified by the Rockwall Central Appraisal District, the appraiser for the District, and submitted to the District's tax assessor/collector;

WHEREAS, the District may levy a maintenance tax on all taxable property in the District to provide for payment of expenses as set out in Section 49.107, Texas Water Code;

WHEREAS, the District has complied with the provisions of Section 49.236, Texas Water Code and has conducted a Public Hearing on Tax Rate as required therein;



NOW THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF ROCKWALL COUNTY MUNICIPAL UTILITY DISTRICT NO. 7 THAT:

- Section 1. There is hereby levied an ad valorem tax of \$0.75 on each \$100.00 of taxable property within the District in order to provide funds for maintenance and operating purposes.
- Section 2. The Rockwall Central Appraisal District, the District's Tax Collector, is hereby authorized to assess and collect the taxes of the District employing the above tax rate.
- Section 3. The taxes levied hereby are due presently and shall be delinquent if not paid by January 31, 2021.
  - <u>Section 4</u>. This Order Setting Tax Rates shall be effective from and after its adoption.
- Section 5. The President or Vice President is authorized to execute, and the Secretary or any Assistant Secretary to attest, this order on behalf of the Board of Directors.
