The Board of Temporary Directors (the "Board" or the "Board of Directors") of Cimarron Shores Water Control and Improvement District (also sometimes referred to herein as the "District") met in special session, open to the public, at 1388 Cimarron Ranch Road, Marble Falls, Texas 78654, inside the boundaries of the District on November 2, 2022, and the roll was called of the members of the Board to-wit:

> Ramesh Adusumilli Siva N Chandu Venkata Kishore Gadde Ravindra Babu Kongara Srini Kamana

All members of the Board were present at the commencement of the meeting. All directors present at the time a vote was taken voted on all items that came before the Board.

Also present were the following consultants: Andy Barrett of Barrett & Associates, PLLC ("Barrett & Associates"); Prabha Cinclair and Shelli Jackson, attorneys, of Miklos Cinclair, PLLC; and Kimberly Studdard, paralegal, of Winstead PC ("Winstead"); Andre Alaya of Hilltop Securities, Inc.; and Tony Plumlee of Willis Environmental Engineering, Inc.

Srinivasa Gogineni, managing member of Cimarron Shores, LLC, the owner of the property comprising the District, was present.

Also present were the following members of the public and neighboring landowners: Judy Bostic, Andy Doefler, and Mary Doefler.

1. The record shall reflect that the Board of Directors was conducting its first meeting since the approval of the Order Granting Petition for Creation of Cimarron Shores Water Control and Improvement District, which created the District and stated the boundaries of the District, a copy of which is attached hereto as **EXHIBIT "A"**, and which order appointed temporary directors to the Board. On August 9, 2022, the above-referenced temporary directors were appointed to the Board by an order of the Commissioners Court for Burnet County, Texas attached hereto as **EXHIBIT "A"**. It was noted that the temporary directors in attendance executed Statements of Officer forms and were administered Oaths of Office.

2. Kimberly Studdard of Winstead informed the Board that they had secured a proposal for the necessary bonds for the directors and public employees (consultants of the District) as well as directors' and officers' liability insurance from McDonald & Wessendorff Insurance, whom acts as agent to hundreds of special districts in the State of Texas. Following a review of the proposals pertaining to the required bonds and the directors' and officers' liability policy, a motion was made by Director Ramesh Adusumilli, seconded by Director Siva N. Chandu, and unanimously carried, that the insurance proposals for such coverage and bonds be approved and accepted.

3. The next business to be addressed was the election of a President, Vice President, Secretary, Treasurer/Assistant Secretary and an additional Assistant Secretary for the Board of Directors as provided by law. Following a full discussion and motion by Director Srini Kamana, seconded by Director Ramesh Adusumilli and unanimously carried, the following slate of officers was elected:

4. Srinivasa Gogineni then gave the Board a brief report with regard to proposed development in the District, noting the total acreage is roughly 647.75 acres with approximately 403 single-family custom-home lots to be developed within approximately two years It was noted that the developer is in receipt of water service commitments from the Lower Colorado River Authority (LCRA). Sewer would be provided onsite.

5. The Board next reviewed and considered a proposal for legal services with the firm of Barrett & Associates, PLLC. Andy Barrett reviewed the terms of such fee agreement with the Board and upon motion by Director Srini Kamana, seconded by Director Ravindra Babu Kongara and unanimously carried, the Board approved said agreement and retained Barrett & Associates as district co-counsel. Prabha Cinclair of Miklos Cinclair, PLLC reviewed the terms of its fee agreement with the Board and upon motion by Director Srini Kamana, seconded by Director Ravindra Babu Kongara and unanimously carried, the Board and upon motion by Director Srini Kamana, seconded by Director Ravindra Babu Kongara and unanimously carried, the Board approved said agreement and retained Miklos Cinclair, PLLC as district co-counsel. In addition, Kimberly Studdard of Winstead PC briefly reviewed the terms of a proposal for legal services with the firm of Winstead and upon motion by Director Srini Kamana, seconded by Director Ravindra Babu Kongara and unanimously carried, the Board approved said agreement and retained Winstead and upon motion by Director Srini Kamana, seconded by Director Ravindra Babu Kongara and unanimously carried, the Board approved said agreement and retained Winstead to provide paralegal services, assist with certain general services in conjunction with Barrett & Associates and Miklos Cinclair, PLLC and to serve as the District's bond counsel.

6. Andy Barrett then reviewed a proposal with Willis Environmental Engineering, Inc. to serve as the District's engineer, and following a review of such proposal and discussion thereof, and upon motion, subject to District's Attorney as to final form, by Director Srini Kamana,

seconded by Director Siva N. Chandu and unanimously carried, the Board approved such Consultant Agreement for Professional Services with Willis Environmental Engineering, Inc.

7. The Board reviewed a proposal from Hilltop Securities, Inc. ("Hilltop Securities") to serve as the District's financial advisor. Andre Ayala explained the firm's qualifications and reviewed such proposal with the Board. Following a review of the proposal and discussion thereof, upon motion by Director Ramesh Adusumilli seconded by Director Srini Kamana and unanimously carried, the Board approved such Financial Advisory Agreement with Hilltop Securities.

8. The Board reviewed an engagement letter and separate Bookkeeping Services Agreement with Bott & Douthitt, PLLC ("Bott & Douthitt") to serve as bookkeeper for the District. Qualifications for such firm were outlined and discussed with the Board. Following such review and discussion, upon motion by Director Srini Kamana seconded by Director Siva N. Chandu and unanimously carried, the Board approved such engagement letter and agreement for bookkeeping services with Bott & Douthitt.

9. Upon motion by Director Ravindra Babu Kongara, seconded by Director Ramesh Adusumilli and unanimously carried, the Board authorized Bott & Douthitt to assist with the opening of a District operating account at ABC Bank and requested that Bott & Douthitt have the necessary resolutions and signature cards available at the next meeting to formally open such account and to further work with the developer in connection with securing an operating advance for such account.

10. The Board then considered and ratified prior actions taken and the payment of various out-of-pocket expenses made on behalf of the District. Upon motion by Director Ramesh Adusumilli, seconded by Director Srini Kamana and unanimously carried, the Board approved such actions.

11. Andy Barrett then gave a brief update with regard to status of negotiations with the City of Marble Falls, Texas, Burnet County and various water service providers and actions as may be necessary with regard to various agreements and matters with same, including working with the engineers on the submission of any necessary permits or other applications to the TCEQ and authorization by the Board for the attorneys to negotiate any necessary agreements and engineers to file any necessary applications. Upon motion by Director Ramesh Adusumilli, seconded by Director Srini Kamana and unanimously carried, the Board approved such negotiations and the filing of such applications.

12. There was presented to the Board a proposed Order Designating Offices Outside the District, which Order designates various offices of the District, declaring them to be public places, a copy of said Order being attached hereto as **EXHIBIT "B"**. After a full discussion, and upon motion of Director Srini Kamana, seconded by Director Ramesh Adusumilli, and unanimously carried, the Board approved said Order Designating Offices Outside the District. The officers were directed to execute said Order, and the attorneys were authorized to publish notice of the designation for such offices outside the District. 13. The Board next reviewed a Resolution Designating Posting Location of Meeting Notices ("Resolution"), a copy of which is attached hereto as **EXHIBIT "C"** and upon motion by Director Srini Kamana, seconded by Director Siva N. Chandu and unanimously carried, the Board adopted said Resolution.

14. There was presented to the Board an impression of the proposed seal of the District, circular in shape with the name of the District around a five-point star. It was duly moved by Director Ramesh Adusumilli, seconded by Director Siva N. Chandu and unanimously carried that said seal be adopted as the legal seal of the District, an impression of which is attached hereto as **EXHIBIT "D"** and that the Secretary or Assistant Secretary or records manager for the District be authorized to affix said seal to all instruments of the District requiring a seal.

15. The Board next reviewed a District Information Form detailing general information about the District that is required to be approved and filed of record with both the Burnet County Clerk and the TCEQ, a copy of which is attached hereto as **EXHIBIT "E"**. Following a review thereof, upon motion by Director Ramesh Adusumilli, seconded by Director Srini Kamana, and unanimously carried, the Board approved such Form and authorized District Attorney, Prabha Cinclair, to file such items with the Burnet County Clerk and with the TCEQ.

16. The Board next reviewed an Order Adopting Code of Ethics, Travel Expense Policy and Establishment of Maximum Annual Limit of Fees of Office, and Procedures for Selection and Review of Consultants, Policies Concerning the Use of Management Information including the Formation of an Audit Committee, Investment Policy, Selection of a Fiscal Year-End and Certain Other Matters, a copy of which is attached hereto as **EXHIBIT "F"**. In connection with review of such policies, Kimberly Studdard explained various provisions of the Open Meetings Law to the Board as relates to the Board members discussion of District business. In addition, it was confirmed that the Board would select December 31st as its fiscal year end. Following a full review and motion by Director Srini Kamana, seconded by Director Siva N. Chandu and unanimously carried, the Board approved said Order.

17. The Board next reviewed an Order Establishing Records Management Program and Appointing Records Management Officer, a copy of which is attached hereto as **EXHIBIT "G"**. Following a full review and motion by Director Siva N. Chandu, seconded by Director Ramesh Adusumilli, and unanimously carried, the Board approved said Order.

18. The Board next reviewed and considered a Resolution Adopting Prevailing Wage Rate Scale for Construction Projects, and any filings as may be necessary with regard thereto in accordance with the Davis-Bacon Act and as required by Texas Government Code Chapter 2258, a copy of which is attached hereto as **EXHIBIT "H"**. Following a full review and motion by Director Ramesh Adusumilli, seconded by Director Srini Kamana, and unanimously carried, the Board approved said Resolution.

19. Ms. Studdard then discussed with the Board the need to create a District website to house various election documents as well as meeting notices and minutes, tax-related documents and budget information, at such time that information is relevant and available, and after a brief discussion and upon motion by Director Ramesh Adusumilli, seconded by Director Siva N. Chandu the Board unanimously approved creation of a District website by Winstead.

20. It was noted that following the election of permanent directors, the Directors would be required to complete certain on-line government training courses pursuant to Chapter 551 of the Texas Government Code and that more details would follow at the Board meeting whereat the District elections would be canvassed. The Board tentatively discussed meeting to canvass such elections, and it was noted that such date would be verified to ensure that it fell within the proper canvassing period and that an invite to such meeting would be sent to confirm such date.

21. Public Comments: Andy Doefler, neighboring landowner, introduced himself and stated that he has served on many boards and is currently retired.

There being no further business to conduct, Director Srini Kamana moved that the meeting be adjourned, which motion was seconded by Director Ramesh Adusumilli, and unanimously approved, and the Board adjourned until further call.



Order Granting Petition for Creation dated August 23, 2022

ORDER GRANTING PETITION FOR CREATION OF CIMARRON SHORES WATER CONTROL AND IMPROVEMENT DISTRICT

The Commissioners Court for Burnet County, Texas, having received a Petition for Creation of Cimarron Shores Water Control and Improvement District (the <u>"Petition"</u>), having posted and provided notice of hearing on the Petition, having held a hearing on the Petition in accordance with the notice and applicable law, and having heard and considered testimony of all persons electing to appear at the hearing, has and does make the following findings:

- 1. The Petition was validly filed in accordance with the provisions of Chapters 49 and 51 of the Texas Water Code.
- 2. The proposed district (the <u>"District"</u>) contains an area of approximately 647.75 acres of land, more or less, situated in Burnet County, Texas, and is described by metes and bounds in **Exhibit A**, which exhibit is attached hereto and incorporated herein for all purposes.
- 3. The property described in **Exhibit** A is not within the extraterritorial jurisdiction of any municipality.
- 4. The purposes for which the District is proposed to be created and organized are allowed under the Texas Water Code.
- 5. The general nature of the work to be done by the District as contemplated at the present time is in compliance with state law.
- 6. Petitioner is the majority of the persons who hold title to land in the District which represents a total value of more than 50 percent of the value of all the land in the District.
- 7. The organization of the District as requested is feasible and practicable.
- 8. The land to be included in, and the residents of, the District will be benefitted by the creation of the District.
- 9. There is a public necessity or need for the District.
- 10. The creation of the District will further the public welfare.

Based upon these findings, it is hereby ORDERED, ADJUDGED, AND DECREED that the Petition be GRANTED in all respects, that the Cimarron Shores Water Control and Improvement District is hereby created, organized and established, and shall exist and have the powers authorized, under the terms and provisions of Article 16, Section 59 of the Texas Constitution, and Chapters 49 and 51 of the Texas Water Code.

It is further ORDERED, ADJUDGED, AND DECREED that the following individuals are hereby named as Temporary Directors, pursuant to Section 51.020 of the Texas Water Code, to serve from this date until their successors are duly elected or appointed as provided by law.







CODE OF ETHICS

SECTION 1. Purpose. The Purpose of this Code of Ethics is to set forth the standards of conduct and behavior for the members of the Board of Directors of CIMARRON SHORES WATER CONTROL IMPROVEMENT DISTRICT (the "District"), and its officers, employees, and persons handling investments for the District (collectively with the Directors, the "District Officials") in accordance with Chapter 171, Local Government Code, as amended.

SECTION 2. Conflicts of Interest. A Director will abstain from participating in a vote or decision on a matter involving a business entity in which the Director has a substantial interest if it is reasonably foreseeable that an action on the matter would confer an economic benefit on the business entity. A Director will abstain from acting as a surety for a business entity that has work, business, or a contract with the District. A Director will abstain from acting as a surety on any official bond required by an officer of the District. For these purposes, a person is considered to have a "substantial interest" in a business if (1) he owns 10% or more of the voting stock or shares of the business entity; or (2) funds received from the business exceed 10% of his gross income for the previous year. A person has a substantial interest in real property if the interest is an equitable or legal ownership with a market value of \$2,500 or more. A Director is considered to have a substantial interest for these purposes if a person related to the Director within the first degree of affinity or consanguinity, as determined under Chapter 573, Government Code, has a substantial interest as defined herein.

A Conflicts Disclosure Statement, Form CIS as provided by the Texas Ethics Commission, is required to be executed by any members of the Board of Directors of the District based on the instructions provided for completing said form. A copy of the latest revised (11/30/15) Form CIS, along with instructions, was provided to each Board member at the time of the adoption of this Code.

ATTACHMENT "B"

TRAVEL EXPENSE POLICY AND ESTABLISHMENT OF MAXIMUM ANNUAL LIMIT ON FEES OF OFFICE

SECTION 1. Purpose. The purpose of this Travel Expense Policy is to set forth the policies of CIMARRON SHORES WATER CONTROL IMPROVEMENT DISTRICT (the "District") concerning travel expenses for members of the Board of Directors of the District at all meetings other than Board meetings.

SECTION 2. Attendance at Meetings. For attendance at conferences, hearings, or other meetings outside the Burnet County area, members of the Board of Directors must be sanctioned by the Board of Directors; attendance at local meetings will be at each Director's discretion, however, such local meetings must relate to the business of the District. Following the meeting, Directors attending any meeting shall report to the Board concerning the meeting.

SECTION 3. Meeting Expenses Outside of the Burnet County area. The District will pay a Directors fee of \$150 per day for days of the meeting and a director fee of \$150 for one travel day. At sanctioned meetings, the District will pay the single room rate for the hotel at which the meeting is being held or any other comparable hotel. For travel connected with attendance at a sanctioned meeting, the District will pay round trip mileage at the current IRS mileage rate for travel by car or round-trip airfare at current commercial rates for standard (not first class) airfare.

SECTION 4. Meeting Expenses for Local Meetings. The District will pay Directors a director fee of \$150 per day and round-trip mileage at the current IRS mileage rate for transportation to the meeting location.

SECTION 5. Reimbursement. Directors attending meetings will submit an itemized expense report to the District's bookkeeper or operations manager, before reimbursement is made. The District's bookkeeper or operations manager will submit such expense report to the Board of Directors for approval. Items on the expense report shall include lodging, meals, reasonable tips, and transportation. Reimbursement for meals will be limited to \$50 per day. Directors sharing expense items may split reported expenses in any matter they deem equitable, but the Board will pay no more than 100% of the actual total cost of reimbursable items.

SECTION 6. Extraordinary Expenses. Any extraordinary expenses for a Director attending a sanctioned meeting must be approved by the Board prior to incurring the expense.

SECTION 7. Maximum Annual Limit on Fees of Office. In accordance with Texas Water Code § 49.060, (a-1), the District establishes a maximum annual limit of fees of office paid to any one director as \$7,200 per year based on a 12/31 fiscal year end.

ATTACHMENT "C"

POLICY CONCERNING SELECTION, MONITORING, REVIEW, AND EVALUATION OF PROFESSIONAL CONSULTANTS

SECTION 1. Purpose. The purpose of this Policy Concerning Selection, Monitoring, Review, and Evaluation of the Professional Consultants is to set guidelines for the Board of Directors for CIMARRON SHORES WATER CONTROL IMPROVEMENT DISTRICT (the "District") concerning its Professional Consultants.

SECTION 2. Definition of Professional Consultant. "Professional Consultant" shall include the District's attorney, auditor, manager, financial advisor, engineer, tax assessor/collector, development consultant and such other consultants other than employees that the District may hereafter engage.

SECTION 3. Selection of Consultants. Whenever the Board of Directors of the District decides to terminate the services of one or more of its Professional Consultants, the Board shall solicit proposals and shall appoint a committee of two Directors to review any proposals received by the Board, to interview applicants if deemed necessary by such committee, and to make a recommendation to the entire Board of Directors concerning the selection.

SECTION 4. Monitoring of Professional Consultants. For those Professional Consultants with annual contracts, the Board of Directors of the District will review the performance of the Professional Consultants for the prior year at the time the contract is renewed. On an annual basis, once the District is operational and required to complete annual audits, the Board of Directors shall review the performance of its other Professional Consultants in connection with the review of its annual financial report or annual audit.

ATTACHMENT "D"

POLICIES RELATING TO USE OF MANAGEMENT INFORMATION AND FORMATION OF AN AUDIT COMMITTEE, INVESTMENT POLICY AND SELECTION OF FISCAL YEAR

SECTION 1. Purpose. The purpose of this Policy Relating to Use of Management Information and Formation of an Audit Committee for CIMARRON SHORES WATER CONTROL IMPROVEMENT DISTRICT (the "District") is to provide written policies concerning use of management information.

SECTION 2. Annual Budgets. Once operations commence, prior to each fiscal year, the Board of Directors of the District shall adopt an annual budget in connection with the operation and management of the District which will be prepared by the District, the District's bookkeeper and proposed operations manager, in which revenues are anticipated for the next fiscal year for use in planning and controlling of costs and shall compare the actual revenues and expenditures of the District to the budgeted revenues and expenditures on a monthly basis. This annual budget shall cover operations expenses and revenue for the District as well as debt service expenses and revenue for the District.

SECTION 3. Audit Committee. At such time as the District is required to conduct annual audits, the District hereby appoints its Board of Directors as an audit committee, or any two such members of the Board that the Board may appoint from time to time to review the annual audit prepared by the District Auditor.

SECTION 4. Accounting Standards. At such time as the District is required to conduct annual audits, the District hereby directs its auditor to adopt uniform auditing reporting requirements that use "Audits of State and Local Governmental Units" as a guide on audit working papers and that uses "Governmental Accounting and Financial Reporting Standards" and any further standards as may be required by the Texas Commission on Environmental Quality, Commission rules or State statutes as may be amended from time to time.

SECTION 5. Investment Policy. At such time as the District has \$10,000 or more in its accounts it shall establish formal Investment Policy.

SECTION 6. Fiscal Year-End. The District adopts December 31 as its fiscal year end.

WHEREAS, the Local Government Records Act, Texas Local Government Code §203.026, requires governing bodies of local governments with assistance from the Records Management Officer of the District (the "RMO") to develop an active and continuous records management program which prescribes policies and procedures consistent with the Local Government Records

Act and in the interest of cost-effective records management; and

WHEREAS, the Local Government Records Act, Texas Local Government Code §203.026(c), requires that a copy of this Order and <u>Exhibit "A"</u> thereto be filed with the Supervisor of the Texas State Library and Archives Commission within thirty (30) days after its adoption by the Board of Directors of the District.

IT IS, THEREFORE, ORDERED BY THE BOARD OF DIRECTORS OF CIMARRON SHORES WATER CONTROL AND IMPROVEMENT DISTRICT THAT:

IV.



EXHIBIT "A"

RECORDS MANAGEMENT PROGRAM

ARTICLE I

<u>General</u>

Section 1.01. Purpose

The purpose of this Records Management Program is to establish, promote and support an active and continuous program for the efficient and economical management of all Records, to cause policies and procedures to be developed, and to facilitate the creation and maintenance of Records that document the organization, functions, policies, decisions, procedures and essential transactions of Cimarron Shores Water Control and Improvement District (the "District").

Section 1.02. Definitions

"Act" means Local Government Records Act, Texas Local Government Code §201.001 - 205.009 as now or hereafter amended.

"Custodian" means the appointed or elected public officer who by the state constitution, state law, ordinance, or administrative policy is in charge of an office that creates or receives local government records.

"Director or Librarian" means the executive and administrative officer of the Texas State Library and Archives Commission.

"Record" means a local government record as defined by section 201.003(8), as may be amended from time to time, of the Act.

"Records Management Officer ("RMO")" means the individual or office appointed from time to time by the Board of Directors of the District to serve as records management officer.

"Records Control Schedule" means a document prepared by or under the authority of a records management officer listing the records maintained by the District, their retention period, and other dispositive information required by the District.

ARTICLE II

Permanent Retention and Records Control Schedule

Section 2.01. Permanent Retention

The District has determined that it will retain all Records permanently. Notwithstanding section 2.02 herein, the District shall not be required to submit Records Control Schedules until such time as the District changes its policy and determines that certain records are not required to be retained permanently.

Section 2.02. Records Control Schedule Preparation

Within thirty (30) days from the date the District determines not to retain all Records permanently and adopts and an Amended Order relating to its records management program, the RMO shall cause to be prepared and presented for approval to the Board of Directors of the District at its meeting following such date, Records Control Schedules and list of obsolete Records for the District, if any. Such Records Control Schedules shall establish retention periods for all Records and is only required to be prepared if the District does not intend to permanently retain all of its records.

ARTICLE III

Records Destruction and Alienation

Section 3.01. Conditions of Destruction

The District or the District's consultant or other designee shall destroy a Record only upon one of the following conditions:

(1) such Record is listed on a Records Control Schedule filed with and approved by the Director pursuant to Section 203.041 of the Act and the retention period listed therein for such Record has expired; or

(2) the Record appears on a list of obsolete Records approved by the Director pursuant to Section 203.044 of the Act; or

(3) if the RMO files a destruction request for the Record with the District or the Director's designee and the Director or such designee approves such request.

Section 3.02. Methods of Destruction

Records shall be destroyed by burning, shredding, pulping, or burial in a landfill or by sale or donation for recycling. The RMO or its designee shall seek assurances from the recycler that any Records sold or donated for recycling shall be rendered unrecognizable as District Records.

Section 3.03. Alienation of Records

Neither the District nor any District consultant or other designee shall sell, donate, loan, or transfer any Record to a private college, university, private museum or library or private organization of any type, or to an individual except with the consent of the Director or the Director's designee and after such Records retention period under the District's Record Control Schedule has passed.

ARTICLE IV

Care and Preservation of Records

Section 4.01. Storage

District Records shall be stored in a secure area free from moisture or any other condition which could damage, alter, or destroy such Records.

Section 4.02. District Ownership of Records

A District consultant or Custodian storing Records for the District shall retain such Records for a period of time consistent with the District's Records Control Schedules. Consultant or Custodian retention or storage of Records does not impair, alter or otherwise change the District's access, control and ownership of such Records.

Section 4.03. Compliance with Open Records Act

All Records shall be held in compliance with the Open Records Act, V.T.C. A., Government Code § 551, as amended.

Section 4.04. Microfilm and Electronic Storage of Records

Pursuant to the Local Government Records Act, V. T. C. A., Local Government Code § 204.001 - 204.011, as amended, the Board of Directors of the District may, at this election, maintain Records on microfilm or store such Records electronically in addition to or instead of the source document in paper.

Section 4.05. District Consultants

Each District consultant who retains District Records shall adequately document the services provided the District by the consultant and shall retain all District Records in accordance with the requirements of this Order. Each District consultant shall provide the District with a letter agreeing to comply with all provisions of this Order in connection with District Records. Such letter shall detail the consultant's method of indexing, storing and protecting District's Records and each such letter shall be filed as part of the District's Records. Exhibit H

Resolution Adopting Prevailing Wage Rate Scale for Construction Project

RESOLUTION ADOPTING PREVAILING WAGE RATE SCALE FOR CONSTRUCTION WORKERS

WHEREAS, Cimarron Shores Water Control and Improvement District (the "District") has heretofore been duly created and organized in Burnet County and

WHEREAS, Chapter 2258, Texas Government Code ("Chapter 2258"), requires the District to determine the general prevailing rate of per diem wages for each craft or type of worker in the locality in which a construction project for the District is to be performed and the general prevailing rate of per diem wages for legal holiday and overtime work; and

WHEREAS, Chapter 2258 provides that a worker employed on a construction project by or on behalf of the District shall be paid not less than said general prevailing rates, as applicable; and

WHEREAS, Chapter 2258 provides that a contractor that is awarded a construction contract for the District, or a subcontractor of the contractor, shall pay not less than the rates determined as set forth above to a worker employed in the execution of such contract for a construction project; and

WHEREAS, Chapter 2258 applies to construction projects paid for in whole or in part from funds of the District, regardless of whether the work is done under the District's supervision or direction; and

WHEREAS, the Board of Directors of the District (the "Board") has used the prevailing wage rate as determined by the United States Department of Labor ("DOL") in accordance with the Davis-Bacon Act (40 U.S.C. § 276a *et seq.*) for Burnet County (the "County") as Prevailing Wage Scale for Construction Projects may be amended from time to time, to determine the general prevailing rate of per diem wages received by classes of workers employed within the District on projects similar to the construction projects of the District and has determined to adopt a Prevailing Wage Rate Scale for Construction Projects for the District; Now, Therefore,

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF CIMARRON SHORES WATER CONTROL AND IMPROVEMENT DISTRICT THAT:

<u>Section 1</u>: The Board has used the prevailing wage rates as determined by the DOL in accordance with the Davis-Bacon Act for the County as Prevailing Wage Scale for Construction Projects may be amended from time to time, in order to determine the general prevailing rate of per diem wages received by classes of workers employed on public works projects within the District.

<u>Section 2</u>: The District hereby adopts the Prevailing Wage Rate Scale for Construction Projects, as adopted by the County as may be relevant for a particular contract, as the Prevailing Wage Scale for Construction Projects may be amended from time to time, which establishes minimum rates that shall be used by all contractors and their subcontractors on construction projects by or on behalf of the District.

<u>Section 3</u>: A contractor or subcontractor on a construction project by or on behalf of the District shall maintain records as required by Chapter 2258 and shall be subject to the penalties, forfeitures, and withholding of money for failure to comply with this Resolution and/or pending a final determination of an alleged violation, as provided in Chapter 2258.

<u>Section 4</u>: The District engineer is hereby directed and authorized to specify the wage rates adopted hereunder in all specifications for bids and contracts for construction projects by or on behalf of the District.
