TO: THE BOARD OF DIRECTORS OF ROCKWALL COUNTY MUNICIPAL UTILITY DISTRICT NO. 9 AND TO ALL OTHER INTERESTED PERSONS:

Notice is hereby given pursuant to V.T.C.A., Government Code §551, that the Board of Directors of Rockwall County Municipal Utility District No. 9 will hold a regular meeting on **Tuesday, May 23, 2023 at 6:00 p.m., at the Hampton Inn at 1549 Laguna Drive, Rockwall, Texas 75087** for the following purposes:

1. Public communication and comment;
2. Review and approve Minutes of April 25, 2023 Board of Directors meeting;
3. Open public bids and award sale of \$6,195,000 Unlimited Tax Road Bonds, Series 2023 (“Series 2023 Road Bonds”);
4. Consider approve and authorize execution of documents for the Series 2023 Road Bond documents, including, but not limited to:
  - a. Bid awarding sale of Series 2023 Road Bonds;
  - b. Bond Order authorizing the issuance of the Series 2023 Road Bonds;
  - c. Pay Agent/Registrar Agreement;
  - d. General and No-Litigation Certificate, and all additional certificates and documents required by the Attorney General to secure necessary approval of and to close the Series 2023 Road Bonds; and
  - e. All additional certificates and documents required to secure the necessary approval of and closing of the Series 2023 Road Bonds.
5. Consider and authorize submission of Transcript of Proceedings to the Texas Attorney General, confirmation of the next Board meeting date in advance of Series 2023 Road Bond closing for approval of an Agreed-Upon Procedures Report, and take any action as may be necessary or related thereto;
6. If timely, hear report from engineer, including authorization of advertisements for construction of additional District improvement projects as may be necessary, award construction contracts, approve pay estimates or change orders relating to on-going projects, approval and acceptance of final projects and conveyances relating to such projects, approve joint facility agreements and hear all engineering related updates and take any action as may be necessary;
7. Hear report from developer and take any action in connection with plat approval, reimbursement agreements, assignment agreements, or other development related items;
8. Review and approve bookkeeping and tax collection reports, and take any action on bookkeeping related matters including quarterly investment reports; investment recommendations; new account related matters; updated list of designated banks; revisions to engagement letter for bookkeeping services; and authorize release of checks as noted on report;

9. Consider review and accept Arbitrage Rebate Calculations report prepared by Arbitrage Compliance Specialists;
10. Discuss tentative date for next meeting; and
11. Adjournment.
