- 5. Consider and authorize District consultants to prepare an application to TCEQ for addition of TWC § 51.331 drainage powers, adopt related resolution, and take any action necessary or appropriate in connection therewith;
- 6. Hear update from developer and take any action in connection with plat approval, reimbursement agreements or assignments thereunder, or other development related items;
- 7. Consider review and approve Interlocal Agreement for Wastewater Treatment Services by and between the District and Kaufman County Fresh Water Supply District No. 7-A;

- 8. Review and approve bookkeeping and tax collection reports, and take any action on bookkeeping related matters including quarterly investment reports; investment recommendations; new account related matters; updated list of designated banks; revisions to engagement letter for bookkeeping services; and authorize release of checks as noted on report;
