

ORDER SETTING TAX RATE FOR 2023

KAUFMAN COUNTY FRESH WATER SUPPLY DISTRICT NO. 1-D §

The Board of Directors of Kaufman County Fresh Water Supply District No. 1-D met in special session, after due notice, at its office outside the boundaries of the District, on the date hereinafter set out; whereupon the roll was called of the members of the Board of Directors, to-wit:

All members of the Board were present with the exception of Director Berry Woods.

WHEREUPON, among other business conducted by the Board, Director Bittner introduced the Order set out below and moved its adoption, which motion was seconded by Director Teal and after a full discussion and the question being put to the Board of Directors, said motion was carried by the following vote:

"Aye" 4; "No" 0.

Order thus adopted is as follows:

WHEREAS, the appraisal roll of Kaufman County Fresh Water Supply District No. 1-D (the "District") for 2023 has been prepared and certified by the Kaufman County Appraisal District, the appraiser for the District, and submitted to the District's tax assessor/collector;

WHEREAS, the District may levy a maintenance tax on all taxable property in the District to provide for payment of expenses as set out in Section 49.107, Texas Water Code;

WHEREAS, the Board of Directors has reviewed and approved its operating budget for its fiscal year April 1, 2023 through March 31, 2024 and has determined what maintenance tax rate should be set to meet such budget requirements; and

WHEREAS, the Board of Directors has reviewed and approved a debt service budget and has determined what debt service tax rate should be set to meet the debt service requirements of the District's outstanding bonds;

WHEREAS, the District has complied with the provisions of Section 49.236, Texas Water Code and has conducted a Public Hearing on Tax Rate as required therein;

NOW THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF KAUFMAN COUNTY FRESH WATER SUPPLY DISTRICT NO. 1-D THAT:

Section 1. There is hereby levied an ad valorem tax of \$0.6371 on each \$100.00 of taxable property within the District in order to provide funds for maintenance and operating purposes.

Section 2. There is hereby levied an ad valorem tax of \$0.3629 on each \$100.00 of taxable property within the District in order to provide for payment of principal and interest and associated obligations on the District's outstanding bonds.

Section 3. The total tax rate for 2023 is \$1.00 on each \$100 of taxable property within the District. All taxes collected pursuant to this levy, after paying costs of levying, assessing, and collecting same, shall be used for paying costs of proper services, engineering and legal fees, and administrative expenses of the District, and for paying principal of an interest on bonds, or other lawfully authorized evidences of indebtedness issued or assumed by the District.

Section 4. The Kaufman County Appraisal District, the District's Tax Collector, is hereby authorized to assess and collect the taxes of the District employing the above tax rate.

Section 5. The taxes levied hereby are due presently and shall be delinquent if not paid by January 31, 2024.

Section 6. This Order Setting Tax Rate shall be effective from and after its adoption.

Section 7. The President or Vice President is authorized to execute, and the Secretary or any Assistant Secretary to attest, this order on behalf of the Board of Directors.


