Notice is hereby given pursuant to Section 551 of the Texas Government Code, that the Board of Directors of Round Rock Municipal Utility District No. 1 will hold a special Board meeting at 8:00 a.m. on December 13, 2023, for the purposes stated herein. 1. Public communications and comments;
2. Review and approve Minutes of November 16, 2023 Board of Directors meeting;
3. Review and approval of an Agreed Upon Procedures Report for expenditures from proceeds of the \$12,000,000 Unlimited Tax Road Bonds, Series 2023 ("Series 2023 Road Bonds"); authorize any additional action or the execution of any documents needed related to the closing of the Series 2023 Road Bonds; and take any action as may be necessary related thereto;
4. Consider review and approve an Amended District Information Form and take any action as may be necessary related thereto;
5. Update from the developer as it relates to the status of development within the District;
6. Update with respect to communications with the City of Round Rock regarding future bonds;
7. Hear engineer's report, review any needed plat approvals, pay applications or change orders under existing contracts, and if timely, take any necessary actions with respect to any plan or plat approvals, authorize any additional formal bidding for construction contracts for additional phases of development, subject to receipt of necessary approvals, review of bids received and recommendation letters from engineer as to award of contracts, award of contracts and authorize notice to proceed, authorize partial or final acceptance of any projects and action with regard to substantial completion or final completion of any on-going contracts, general discussions with regard to construction and bond services and take necessary action with respect thereto;
8. Review and approve Cash Activity Report and related payments, approve necessary fund transfers, and take further action with regard to any additional reporting or budget related matters;
9. Hear Operations Report and take any necessary action with respect thereto;
10. Discuss the date for the next Board Meeting; and
11. Adjournment.

The Board of Directors will go into Executive Session, if necessary and appropriate, pursuant to the applicable section of Subchapter D, Chapter 551, Texas Government Code Annotated, the Texas Open Meetings Act, on any matter that may come before the Board.
