Notice is hereby given pursuant to V.T.C.A., Government Code §551, that the Board of Directors of Kaufman County Fresh Water Supply District No. 1-A (“District”) will hold a public meeting on **Thursday, January 25, 2024, at 1:00 p.m. at 2728 N. Harwood Street, Suite 500 Dallas, Texas 75201**, an office located outside the boundaries of the District for the following purposes:

1. Call to order;
2. Public comment and communication;
3. Consider review and approve amendment to Cost-Sharing Agreement Regarding Expansions of Water Supply and Wastewater Treatment Facilities by and between the District, Kaufman County Fresh Water Supply District No. 1-C (“KC1C”), and Kaufman County Fresh Water Supply District No. 1-D (“KC1D”) dated May 1, 2021, and take any action necessary or appropriate;
4. Consider review and approve amendment to Joint Utility and Wholesale Allocation Agreement dated August 1, 2008, and take any action necessary or appropriate;
5. Consider discussion regarding wastewater plant lease with AUC Group, LLC, cost sharing between Districts, and operation and conveyance of wastewater treatment plant and related leases to KC1C;
6. Consider discussion regarding settlement of lawsuit with AUC Group, LLC, and take any action necessary or appropriate;
7. Consider review and acceptance of engineer’s report, and take any action necessary or appropriate;
8. Hear report from developer and take any action in connection with plat approval, reimbursement agreements or assignments thereunder, or other development related items;
9. Consider review and acceptance of operator’s report, and take any action necessary or appropriate regarding utility accounts and communication; repair of District facilities; and security of District facilities;
10. Consider review and approve bookkeeping report, and take any action on bookkeeping related matters; budget; new account related matters, update list of designated banks, revisions to bookkeeping services; and authorize release of checks as noted on report;

11. Discuss tentative date for next meeting; and
12. Adjournment.
