

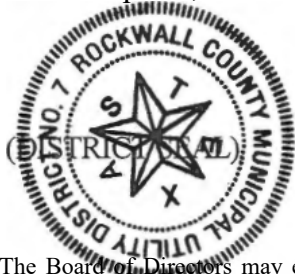
## ROCKWALL COUNTY MUNICIPAL UTILITY DISTRICT NO. 7

TO: THE BOARD OF DIRECTORS OF ROCKWALL COUNTY MUNICIPAL UTILITY DISTRICT NO. 7 AND TO ALL OTHER INTERESTED PERSONS:

Notice is hereby given pursuant to V.T.C.A., Government Code §551, that the Board of Directors of **Rockwall County Municipal Utility District No. 7** (“District”) will hold a regular meeting on **Tuesday, April 16, 2024 at 5:30 p.m., at the Hampton Inn at 1549 Laguna Drive, Rockwall, Texas 75087** for the following purposes:

1. Call to order;
2. Public communications and comments;
3. Review and approve Minutes of March 19, 2024 Board of Directors Meeting;
4. Review and consider approval of the Preliminary Official Statement, set the sale date, and authorize publication of Notice of Sale in connection with the sale of Unlimited Tax Bonds, Series 2024 (the “Series 2024 Utility Bonds”);
5. If timely, consider authorization of District consultants to prepare an Agreed-Upon Procedures Report in connection with the Series 2024 Utility Bonds, and take any action as may be necessary or related thereto;
6. Consider and acknowledge representation letter from McCall Gibson Swedlund Barfoot PLLC;
7. Consider discussion regarding tax exemptions, and take any action as may be necessary;
8. Hear report from engineer, including authorization of any advertisements for construction of additional District improvement projects as may be necessary; award any construction contracts, approve any pay applications or change orders relating to on-going projects and hear all engineering related updates and take any action as may be necessary;
9. Hear report from developer and take any action in connection with plat approval, reimbursement agreements or assignments thereunder, or other development related items;
10. Review and approve bookkeeping report, and take any action on bookkeeping related matters including quarterly investment reports; investment recommendations; new account related matters; updated list of designated banks; revisions to engagement letter for bookkeeping services; and authorize release of checks as noted on report;
11. Consider review of District’s Arbitrage Rebate and Yield Restriction Compliance Service Program;
12. Discuss tentative date for next meeting; and
13. Adjourn.
