

ORDER SETTING TAX RATE
FOR 2024

ROUND ROCK MUNICIPAL UTILITY DISTRICT NO. 1 §

The Board of Directors of Round Rock Municipal Utility District No. 1 ("District") convened in regular session, open to the public and after due notice, at its meeting place outside the District located at KB Homes Office, 10800 Pecan Park, Suite 200, Austin, Texas 78750, on September 11, 2024 hereinafter set out; whereupon, the roll was called of the members of the Board of Directors, to-wit:

All members of the Board were present.

WHEREUPON, among other business conducted by the Board, Director Halm introduced the Order set out below and moved its adoption, which motion was seconded by Director Schwartz and, after full discussion and the question being put to the Board of Directors, said motion was carried by the following vote:

"Aye" 5; "No" 0.

The Order thus adopted is as follows:

WHEREAS, the certified appraisal roll of the District for 2024 has been prepared and certified by the Williamson Central Appraisal District, the appraiser for the District, and submitted to the District's tax assessor/collector;

WHEREAS, the District may levy a maintenance tax on all taxable property in the District to provide for payment of expenses as set out in Section 49.107, Texas Water Code; and

WHEREAS, the Board of Directors has reviewed and approved its operating budget for its fiscal year October 1, 2024 through September 30, 2025 and has determined what maintenance tax rate should be set to meet such budget requirements;

NOW THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF ROUND ROCK MUNICIPAL UTILITY DISTRICT NO. 1 THAT:

Section 1. There is hereby levied an ad valorem tax of \$0.1183 on each \$100.00 of taxable property within the District in order to provide funds for maintenance and operating purposes.

Section 2. There is hereby levied an ad valorem tax of \$0.4490 on each \$100.00 of taxable property for Road Debt Service and \$0.1127 per \$100 of taxable property for Utility Debt Service within the District in order to provide for payment of principal of and interest and associated obligations on the District's outstanding bonds and refunding bonds.

Section 3. The total tax rate for 2024 is \$0.6800 on each \$100.00 of taxable property within the District. All taxes collected pursuant to this levy, after paying costs of levying, assessing, and collecting same, shall be used for planning, maintaining, repairing, and operating the District's facilities and for paying costs of proper services, engineering and legal fees, and administrative expenses, and for paying principal of and interest on bonds, or other lawfully authorized evidences of indebtedness issued or assumed by the District.

Section 4. Larry Gaddes, the Williamson County Tax Assessor/Collector, is hereby authorized to assess and collect the taxes of the District employing the above tax rate.

Section 5. The taxes levied hereby are due presently, and shall be delinquent if not paid by January 31, 2025.

Section 6. This Order Setting Tax Rate shall be effective from and after its adoption.


Section 7. The President or Vice President is authorized to execute, and the Secretary or any Assistant Secretary to attest, this order on behalf of the Board of Directors.

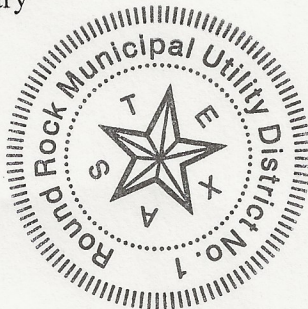


