## NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The total amounts of bonds payable wholly or partly from property taxes approved by the voters, excluding refunding bonds that are separately approved by the voters, are \$27,180,000 for water, sewer, and drainage facilities, and \$25,270,000 for roads. The aggregate initial principal amounts of all such bonds issued are \$16,550,000 for water, sewer, and drainage facilities, and \$19,920,000 for roads.

The District is located in whole or in part within the extraterritorial jurisdiction of the City of Fate. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved.

The purpose of this District is to provide water, sewer, drainage, flood facilities, roads, streets, or other types of facilities or services. The cost of District facilities is not included in the purchase price of your property. The legal description of the property which you are acquiring is as follows:
