Notice is hereby given pursuant to V.T.C.A. Government Code, Section 551, that the Board of Directors of Smiley Road Water Control and Improvement District No. 2 (“District”) will hold a special meeting on **Monday, August 25, 2025, at 8:15 a.m. at 2595 Dallas Parkway, Suite 101, Frisco, Texas 75034**, a meeting place located outside the boundaries of the District, for the following purposes:

1. Call to order;
2. Public communications and comments;
3. Consider and approve the Minutes of the July 15, 2025 Board of Directors Meeting;
4. Consider review and acceptance of engineer’s report including:
 - a. Status of construction projects within the District;
 - b. Authorizing preparation of construction plans/specifications for water, sewer, and drainage and paving improvements;
 - c. Consider approval/ratification of construction plans and specifications;
 - d. Consider approval/ratification of bid advertisements for construction projects;
 - e. Consider approval/ratification of award of contracts for construction projects;
 - f. Consider approval/ratification of contractor pay estimates, change orders; and
 - g. Consider acceptance of certificate of completion.
5. Hear update from developer and take any action in connection with plat approval or other development related items;
6. Consider review and approve cost sharing agreement for operation and maintenance expenses;
7. Consider review and accept easements for drainage, temporary drainage, sidewalks, and temporary construction;
8. Consider review and approve Property Maintenance Agreement by and between the homeowners’ association and the District;
9. Review and approve bookkeeping and tax collection reports, budget, and take any action on bookkeeping related matters including quarterly investment reports; investment recommendations; new account related matters; updated list of designated banks; revisions to engagement letter for bookkeeping services; adoption of financial policies; and authorize release of checks as noted on report;
10. Review and approve annual renewal of insurance and bonds;

11. Discuss tentative date for next meeting; and

12. Adjournment.
