
Notice is hereby given pursuant to V.T.C., Government Code §551, that the temporary Board of Directors of Howe Municipal Utility District No. 1 (the "District") will hold a special meeting on **Thursday, September 18, 2025 at 1:00 p.m. at Winstead PC, 2728 N. Harwood Street, Suite 500, Dallas, Texas 75201**, an office located outside the boundaries of the District for the following purposes:

1. Call to order;
2. Public comment and communication;
3. Review and approve organization minutes of August 11, 2025 Board of Directors meeting;
4. Qualify Directors and administer statement of officer forms and oaths of office, consider and review Conflict of Interest Questionnaire for local governmental officials, and discuss government training pursuant to Chapter 551 of the Texas Government Code;
5. Consider reorganization of the Board of Directors;
6. Consider discussion regarding exclusion of land, adoption of Order Calling Public Hearing on Exclusion of Land, and authorization of publication of Notice of Hearing;
7. Consider review and acceptance of engineer's report, and take any action necessary or appropriate;
 - a. Status of construction projects within the District;
 - b. Consider authorizing preparation of construction plans/specifications for water, sewer, drainage, paving and recreational facilities or repair/modification of existing facilities;
 - c. Consider approval/ratification of construction plans and specifications;
 - d. Consider approval/ratification of advertising for bids for contract(s);
 - e. Consider approval/ratification of award of construction contract(s);
 - f. Consider approval/ratification of contractor pay estimates, change orders and engineering fee statements;
 - g. Consider acceptance of certificate of completion; authorize final acceptance of facilities; and
 - h. Consider approval/ratification of repair and/or maintenance of District facilities;
8. Hear report from developer and take any action in connection with plat approval, reimbursement agreements, consent to Assignments, or other development related items;
9. Consider review and approve Operating Costs and Facilities Reimbursement Agreement;

10. Consider and approve engagement letter of financial advisor for the District and execute related agreement;
11. Consider and approve bookkeeper's report, including authorizing the payment of invoices presented;
12. Discuss tentative date for next meeting; and
13. Adjournment.
