1. Public communication and comments;
2. Review and approve Minutes of September 15, 2025 Board of Directors' meeting;
3. Review and approve Amended District Information Form to reflect current tax rate and authorize filing with the TCEQ and the Waller County;
4. Hear engineer's report, review any needed plat approvals, pay applications or change orders under existing contracts, and if timely, take any necessary actions with respect to any plan or plat approvals, authorize any additional formal bidding for construction contracts for additional phases of development, subject to receipt of necessary approvals, review of bids received and recommendation letters from engineer as to award of contracts, award of contracts and authorize notice to proceed, authorize partial or final acceptance of any projects and action with regard to substantial completion or final completion of any on-going contracts, general discussions with regard to construction and bond services and take any necessary action with respect thereto;

Consideration and, if necessary, possible action with regard to existing District Engineering Agreement, including preparation of any formal Notice of Termination thereof and approval of removal of R.G. Miller Engineers as engineers for the District and any other necessary action with respect thereto;
6. Consideration, review, and approval of engagement of Civil & Environmental Consultants, Inc., as engineers for the District and execute related agreement(s);
7. Update from the developer as it relates to the status of development within the District;
8. Hear report from MuniCap, Inc. and take any necessary action with respect thereto;
9. Review and approve Cash Activity Report and related payments, approve necessary fund transfers, and take further action with regard to any additional reporting or budget related matters;
10. Discuss the next proposed meeting date; and
11. Adjournment.
