Notice is hereby given pursuant to V.T.C.A., Government Code §551, that the Board of Directors of Kaufman County Fresh Water Supply District No. 1-A (“District”) will hold a public meeting on **Wednesday, January 7, 2026, at 12:00 noon at 2728 N. Harwood Street, Suite 500 Dallas, Texas 75201**, an office located outside the boundaries of the District for the following purposes:

1. Call to order;
2. Public comment and communication;
3. Review and approve Minutes of December 3, 2025 Board of Directors meeting;
4. Consider review and acceptance of engineer’s report, and take any action necessary or appropriate;
 - a. Status of construction projects within the District;
 - b. Consider authorizing preparation of construction plans/specifications for water, sewer, drainage, paving and recreational facilities or repair/modification of existing facilities;
 - c. Consider approval/ratification of construction plans and specifications;
 - d. Consider approval/ratification of advertising for bids for contract(s);

 - h. Consider approval/ratification of repair and/or maintenance of District facilities;
5. Consider review and approve Right of Entry Agreement relative to drainage maintenance;
6. Hear report from developer and take any action in connection with plat approval, reimbursement agreements, consent to Assignments, or other development related items;
7. Consider conveyance of real property relative to wastewater treatment plant, and take any action related thereto;
8. Consider review and acceptance of operator’s report, and take any action necessary or appropriate regarding utility accounts and communication; repair of District facilities; and security of District facilities;

9. Consider review and approve bookkeeping report, and take any action on bookkeeping related matters; budget; new account related matters, update list of designated banks, revisions to bookkeeping services; and authorize release of checks as noted on report;
10. Consider and adopt Resolution Adopting Prevailing Wage Rate Scale for Construction Projects;
