12. Adjournment.

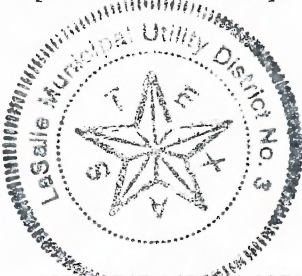
