

ORDER CALLING DIRECTOR ELECTION

THE STATE OF TEXAS §

WEBB COUNTY MUNICIPAL UTILITY DISTRICT NO. 1 §

The Board of Directors (the “Board”) of Webb County Municipal Utility District No. 1 (sometimes referred to herein as the “District”) met in special session, open to the public, at Brittingham Companies, 5810 San January 22, 2026 5, 2024 at 9:30 a.m. and the roll was called of the members of the Board of Directors, (herein referred to as the “Board”) to-wit:

All members of the Board were present.

WHEREUPON, among other business conducted by the Board, Director Haynes introduced the Order set out below and moved its adoption, which motion was seconded by Director De Llano and, after full discussion and the question being put to the Board of Directors, said motion was carried by the following vote:

"Aye" 5 . "No" 0 .

The Order thus adopted is as follows:

WHEREAS, pursuant to Texas Water Code §49.103, it is necessary that an election be held for Webb County Municipal Utility District No. 1 for the election of three (3) Directors, each of whom shall serve a four (4) year term; and

WHEREAS, this Board of Directors wishes to proceed with the ordering of said election.

NOW THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF WEBB COUNTY MUNICIPAL UTILITY DISTRICT NO. 1 THAT:

Section 1: The matters and facts set out in the preamble of this Order are hereby found and declared to be true and complete.

Section 2: An election shall be held on May 2, 2026, between the hours of 7:00 a.m. and 7:00 p.m. at all regular election day polling locations within Webb County, Texas designated by the Elections Administrator of Webb County (“Elections Officer”) and approved by the Webb County Commissioners Court for use in the May 2, 2026 District elections, such detailed listing being set out in the attached Exhibit “A”, at which time the election of three (3) directors, each of whom shall serve a four (4) year term, shall be submitted to the duly qualified voters of the District.

The election will be conducted pursuant to the terms and conditions of that certain Joint Election Agreement between Webb County and the Local Political Subdivisions participating in the May 2, 2026 elections and also in accordance with the separate Contract for Election Services between the District and the Webb County Election Administrator (referred to collectively as the “Election Agreements”) and any amendments thereto.

Section 3: Voting in said election shall be by the use Elections System and Software ("ES&S") ExpressVote Universal Voting System Version 6020 in conjunction with the DS200 Digital Precinct Scanner, conforming to the requirements of the Texas Election Code or, in the event of equipment failure, by separate paper ballots. The ballots used in the election shall have printed thereon the names of all candidates for the office of director who filed applications to have their names appear on the ballot by 5:00 p.m. on February 13, 2026 and a blank space for each write-in candidate. The deadline for write-in candidates to file a declaration of write-in candidacy is 5:00 p.m. on February 17, 2026.

Section 4: Early voting by personal appearance shall be conducted at all Webb County Early Voting locations on the dates and times designated by the Webb County Elections office and attached hereto as Exhibit “B”, which location is designated as a public place within Webb County, Texas. The Webb County Elections Administrator shall appoint qualified Clerks for early voting for said election. The early voting clerk’s mailing address to which ballot applications and ballots to be voted by mail may be sent is Webb County Elections, 1110 Washington St #103, Laredo, Texas 78040 – Attention: Early Voting Clerk. The Early Voting Clerk may be reached by telephone at (956) 523.4050. Additional information may be found at <https://www.webbcountytx.gov/ElectionsAdministration/>.

Section 5: The Elections Officer shall be responsible for the appointment of qualified judges, clerks and other election personnel to assist in the conduct of the election as provided in the Election Agreements. The election shall be held and conducted and returns made to this Board of Directors in accordance with the Election Agreements and in accordance with the Texas Election Code as modified by Chapter 49, Texas Water Code.


Section 6: All qualified resident electors of the District shall be entitled to vote in the election.

Section 7: The Secretary of the Board is hereby directed to cause notice of this election to be posted within the District.

Section 8: Nothing herein shall be construed to prohibit the Board of Directors from canceling the election called hereunder if and as allowed in accordance with the provisions of Chapter 2, Subchapter C, Texas Election Code, as amended.




