

**ORDER DECLARING UNOPPOSED CANDIDATES
ELECTED AND CANCELING ELECTION**

ROCKWALL COUNTY MUNICIPAL UTILITY DISTRICT NO. 6 §

The Board of Directors of Rockwall County Municipal Utility District No. 6 met in regular session, open to the public, after due notice, at its regular meeting place outside the District, on the date hereinafter set out; whereupon the roll was called of the members of the Board of Directors ("Board"), to-wit:

Sherry Kent Skinner	Vice President
Bobbie Hubbard	Secretary
Peggy Smith	Treasurer/Assistant Secretary
Bobby L. Jackson, Jr.	Assistant Secretary

All members of the Board were present with the exception of Director Thrasher.

WHEREUPON, among other business conducted by the Board, Director Jackson introduced the Order set out below and moved its adoption, which motion was seconded by Director Hubbard after a full discussion and the question being put to the Board, said motion was carried by the following vote:

"Aye": 4; "No": 0.

WHEREAS, in accordance with Subchapter C, Section 2.052 of the Texas Election Code, as amended, the Board is in receipt of formal certification acknowledging that candidates in the District's upcoming May 2, 2026 Directors Election are unopposed; and

WHEREAS, Subchapter C, Section 2.053 of the Texas Election Code, as amended, provides that the governing body of a political subdivision by order or ordinance may declare each unopposed candidate elected to the office and formally cancel such election.

NOW THEREFORE BE IT ORDERED BY THE BOARD OF DIRECTORS OF ROCKWALL COUNTY MUNICIPAL UTILITY DISTRICT NO. 6 THAT:

Section 1: The matters and facts set out in the preamble of this order are hereby found and declared to be true and complete.

Section 2: The Board hereby declares Richard Attar; Bobbie Hubbard; and Bobby L. Jackson, Jr. the only formal candidates for director in the District's proposed May 2, 2026 Directors Election, who are unopposed in such election to be hereby elected and that the May 2, 2026 Directors Election be hereby canceled due to the withdrawal of candidate Sherry Skinner.

Section 3: The Board hereby directs that a copy of this Order shall be posted on Election Day at the District's polling place which would have been used in such election.


Section 4: A notice stating that the election will not be held must be posted on or before the commencement of early voting at the District's polling place which would have been used in such election.

Section 5: A Statement of Officer Form (also referred to as the Pre-Oath Statement) must be executed by Richard Attar, Bobbie Hubbard and Bobby L. Jackson, Jr. prior to the swearing in of such candidates.


Section 6: After Election Day (May 2, 2026), the Board of Directors will issue a Certificate of Election to the unopposed candidates who shall be sworn into office in the same manner provided for candidates elected at an election and who shall serve for four (4) years.

Section 7: The President or Vice President is hereby authorized to execute and the Secretary or any Assistant Secretary is hereby authorized to attest this Order and to have such Order formally posted at the District's polling place on the upcoming May 2, 2026 formal election date.


