Notice is hereby given pursuant to Texas Government Code, Section 551, that the Board of Directors of Williamson County Municipal Utility District No. 49 will hold a Special Meeting on April 8, 2026 at 11:30 a.m. for the purposes stated herein. 1. Public communication and comments;
2. Review and approve Minutes of February 11, 2026 Board of Directors meeting;
3. Discussion and possible action regarding upcoming election matters, including review of letter confirming candidates who filed for a place on the ballot. If appropriate, consider and adopt Order Declaring Unopposed Candidates Elected and Canceling Election and authorizing notice thereof;
4. Update from the developer as it relates to the status of development within the District;
5. Review and approve: (i) Acknowledgement, Agreement and Consent to Sale and Assignment Agreement with the National Finance Authority ("NFA"), (ii) District Certificate, (iii) any related documents regarding the NFA Texas Special Revenue Capital Appreciation Bond issuance currently underway by the developer, and issue any other approvals as necessary;
6. Hear engineer's report, review any needed plat approvals, pay applications or change orders under existing contracts, and if timely, take any necessary actions with respect to any plan or plat approvals, authorize any additional formal bidding for construction contracts for additional phases of development, subject to receipt of necessary approvals, review of bids received and recommendation letters from engineer as to award of contracts, award of contracts and authorize notice to proceed, authorize partial or final acceptance of any projects and action with regard to substantial completion or final completion of any on-going contracts, general discussions with regard to construction and bond services and take necessary action with respect thereto;
7. Review and approve Cash Activity Report and related payments, approve necessary fund transfers, and take further action with regard to any additional reporting or budget related matters;
8. Discuss and confirm the next proposed meeting date; and
9. Adjournment.

The Board of Directors will go into Executive Session, if necessary and appropriate, pursuant to the applicable section of Subchapter D, Chapter 551, Texas Government Code Annotated, the Texas Open Meetings Act, on any matter that may come before the Board. No action decision or vote on any subject or matter may be taken unless specifically listed on the agenda for this meeting.
