

**ORDER AND NOTICE DECLARING UNOPPOSED CANDIDATES ELECTED
AND CANCELING ELECTION**

The Board of Directors (the "Board") of Webb County Municipal Utility District No. 1 (sometimes referred to herein as the "District") met in special session, open to the public, at Brittingham Companies, 5810 San Bernardo Avenue, Suite 103, Laredo, Texas 78045, a designated office outside the District, on March 26, 2026 at 10:00 a.m. and the roll was called of the members of the Board of Directors, (herein referred to as the "Board") to-wit:

All members of the Board were present except Director Palacios.

WHEREUPON, among other business conducted by the Board, Director Guajardo introduced the Order set out below and moved its adoption, which motion was seconded by Director De Llano, and after a full discussion and the question being put to the Board of Directors, said motion was carried by the following vote:

"Aye" 4; "No" 0.

WHEREAS, in accordance with Subchapter C, Section 2.052 of the Texas Election Code, as amended, the Board is in receipt of formal certification acknowledging that candidates in the District's upcoming May 2, 2026 Directors Election are unopposed; and

WHEREAS, Subchapter C, Section 2.053 of the Texas Election Code, as amended, provides that the governing body of a political subdivision by order or ordinance may declare each unopposed candidate elected to the office and formally cancel such election.

NOW THEREFORE BE IT ORDERED BY THE BOARD OF DIRECTORS OF WEBB COUNTY MUNICIPAL UTILITY DISTRICT NO. 1 THAT:

Section 1: The matters and facts set out in the preamble of this order are hereby found and declared to be true and complete.

Section 2: The Board hereby declares Jose A. Palacios, Chris M. Haynes, and Antonio Savignon the only formal candidates for director in the District's proposed May 2,

2026 Directors Election, who are unopposed in such election, to be hereby elected and that the May 2, 2026 Directors Election be hereby canceled.


Section 3: A Statement of Officer Form (also referred to as the Pre-Oath Statement) must be executed by such candidates prior to the swearing in of such candidates.

Section 4: After election day, May 2, 2026, the Board of Directors will issue a Certificate of Election to the unopposed candidates who shall be sworn into office in the same manner provided for candidates elected at an election and who shall serve for a four (4) year term.

Section 5: The Board hereby directs that a copy of this Order be posted as notice of cancelation of the May 2, 2026 Directors Election, during the period for early voting by personal appearance and on election day, at the early and regular election day polling places which would have been used in such election.


